ELIGIBILITY

- Entry is open to people holding active memberships to both the Campbell River Art Gallery (\$35) **and** the Campbell River Arts Council (\$25).
- Members can submit **one** original piece each.
- The artwork must have been created in the last three years and must not have been previously shown at the Gallery.
- This is an un-juried exhibition. People's Choice Awards will be given at the end of the exhibition based on votes cast during the show (one vote per visit).

SUBMISSION GUIDELINES

- Please print legibly or submit your information electronically to ensure no mistakes are made with names and titles.
- Label and identify your artwork by printing and filling out the 'artwork label' found on the last page. The label must be affixed to the back, or base, of your artwork.
- Your artwork must remain on display for the duration of the exhibition.
- Send one high-resolution digital image of your artwork to: admin@crartgallery.ca
- The CRAG and CRAC have the right of refusal of any artwork.
- Submit your completed form to the **Campbell River Art Gallery** office by hand or email (admin@crartgallery.ca). Late or incomplete applications will not be accepted.

2D ARTWORK

- Maximum size: 36" x 48" (91.5cm x 122cm)
- Must be ready to hang with proper and secure hanging hardware (only visible from the back of the artwork). Pieces with poor hardware will not be displayed. If you require assistance, or guidance, please call the CRAG at (250) 287-2261.

3D, VIDEO OR DIGITAL ARTWORK

- You must outline installation requirements, providing any support that may be necessary. Provide file type and duration. Please consult Barbara Neff, Director of the Campbell River Art Gallery to ensure the CRAG's ability to show the work as intended.
